TERMS AND CONDITIONS

- The undersigned authorizes Sunrise Market to contact all references given and to enquire as to the customer's credit enquire as to the customer's credit history as well as to report to credit bureaus, collections agencies or any other companies in which there is a financial interest. Upon arrival, the customer agrees to abide by the terms and conditions of the sale pertaining to the products purchased on credit. The customer will remit payment for merchandise purchase in accordance with the terms and conditions granted herein by Sunrise Market unless otherwise stipulated in writing.
- All accounts are COD. In the event that credit is extended, repayment must be made in accordance with the terms outlined on the invoice. Sunrise Market reserves the right to revoke any credit facility at any time and without notice. In such case, any amounts outstanding on the account at the time the credit facility is revoked will be immediately due, regardless of the terms presented on the invoice. All accounts that are on COD terms that result in the order being returned to Sunrise Market, if cash is not available on delivery a \$100.00 service fee will apply.
- In the event that payment is not received and processed by Sunrise Market in accordance with the terms outlined on the invoice or in the case of an immediate demand on account, due to credit facility restriction, an interest charge of 24% per annum (2% per month) will be applied.
- In the event that a payment is returned or not honoured by the customer's bank or credit card company, regardless of the reason for return, a processing fee of \$50.00 will be applied.
- a) It is the customer's responsibility, upon delivery, to count the total number of pieces received to ensure that the number corresponds with the total number of pieces presented on the invoice. The customer must sign Sunrise Market's delivery manifest indicating that the correct number and type of pieces were, in fact, received in the appropriate condition required. Claims for shortages cannot be made if more than 24 hours has elapsed since the delivery manifest has been signed by the customer, one of their employees or any related personnel acting on behalf of the customer.
 b) It is the customer's responsibility to notify Sunrise Market's head office within 24hrs of delivery, of any cases found damaged as a result of delivery. Only full cases will be accepted for credit; single units will not be accepted.
- The customer acknowledges and accepts that Sunrise Market shall retain title to the merchandise delivered until the customer pays all amounts owing in respect to such merchandise. Furthermore, as a security for payment of the customer's indebtedness to Sunrise Market at the date hereof or which may here after occur, and for the observances and performance of all the customer's other obligations to Sunrise Market, the customer here by grants a security interest to Sunrise Market in all inventory supplied and all book debts including discounts, refunds or rebates from Sunrise Market (all hereinafter referred to as the "collateral") now owned or hereinafter acquired by the customer and all proceeds thereof in whatever for arising from any transfer, sale or other dealing with the collateral. The undersigned agrees that Sunrise Market may register a financing statement with the Ministry of Consumer and Corporate Relations.
- If a limited company succeeds a sole proprietorship or partnership, or a change of status or any other change from the information provides on Sunrise Market's "Customer File" occurs, which may affect the obligations of the undersigned, the undersigned undertakes to provide all such information to Sunrise Market by registered mail. Notwithstanding such notices, the customer acknowledges that it shall remain liable for all debts incurred, regardless of the change of status unless Sunrise Market specifically releases said parties in writing.
- The customer hereby certifies that the information provided within this application and any other financial information furnished in connection herewith, is true and correct and that this information is being furnished to Sunrise Market for the purpose of extending credit.
